What are we doing to ensure everyone's privacy and safety during classes?

- In the Lead follows all protocols and guidelines required by the school
- The facilitators and staff participating are in private spaces and using earbuds to ensure conversation privacy
- Participant to participant private chat will be disabled
- Screen sharing for participants will be disabled
- Nothing will be recorded and the chats will not be saved
- Students can only join the meeting from the "waiting room" where they will be brought in by the host (ITL staff)
- Breakout rooms will always be supervised
- We can remove last names if necessary from the video and chat
- Coach participants have all passed screening protocols and have also agreed to our standards of online safety and privacy

- Participate in a private setting and if you cannot be alone the expectation is that headphones or earbuds are used so conversations will not be overheard
